1. The Revolutionary Government of Zanzibar through Zanzibar Shipping Corporation intends to dispose three public vessels MV Maendeleo, MT Ukombozi and MV Mapinduzi II. The assets are disposed on “as is, where is” basis and the procuring entity shall have no further liability after sale.
2. The Zanzibar Shipping Corporation now invites Tenders for the purchase of MV Maendeleo, MT Ukombozi and MV Mapinduzi II.
3. The Vessels are categorized in three Lots as follows:-
 - a. Lot 1 – MV Maendeleo
 - b. Lot 2 – MV Mapinduzi II
 - c. Lot 3 – MT Ukombozi

Bidders are allowed to quote for either a lot or all lots.
4. Tendering will be conducted through the International Competitive Bidding procedures specified in the Public Procurement and disposal of public assets Act No. 11 of 2016 and its regulations of 2021 and open to all Tenderers as defined in the Regulations.

5. Interested Tenderers may inspect the MV Maendeleo in Mombasa Kenya at African Marine dock yard while MV Mapinduzi II and MT Ukombozi are at Zanzibar Port.
6. The Shipping Corporation of Zanzibar arrange for the visit of MT Ukombozi and MV Mapinduzi II on 25th May 2022 at 11:00am. Otherwise tenderer may plan for their inspection at any date and time at their own cost one day before opening date with prior information of the seller.
7. Interested eligible Tenderers may obtain further information by obtaining a complete set of the Tendering Documents in English language from the office of the Tender Board Secretary of the Zanzibar Shipping Corporation from 5TH May, 2022 - 8:00am to 15:30pm of the working days, email: pmu@shipco.go.tz
8. Tenderers are required to submit with written letter to purchase bidding documents and pay tender participation fee of one Hundred US Dollar (USD 100) **which is not be refundable** to the following bank account: **ACCOUNT NUMBER: 0404384000, ACCOUNT NAME: FOREIGN SHIPPING LINE, BANK NAME: THE PEOPLE'S BANK OF ZANZIBAR LTD.**
9. All Tenders shall be accompanied by a Tender Security in the form of Unconditional Bank Guarantee from accepted financial institution in the amount of **2%** of the bid amount in Tanzania Shillings or any other freely convertible currencies.
10. All tenders shall be properly filled in and enclosed in plain envelopes must be delivered to Secretary of tender board, Zanzibar Shipping Corporation, Malindi Kinu cha Taa, on or before 10:00 am local time on Wednesday 15th June 2022.
11. Tenders will be opened promptly in the presence of Tender board members and bidders representatives who choose to attend in the opening ceremony at the Zanzibar Shipping Corporation Malindi Kinu cha Taa.
